- b) Attested copy of PAN card.
- c) Copy of valid GST registration Certificate and acknowledgement of up to date filed returns with ARN (Application Reference Number) generated on GST common portal.
- 5. Declaration of the works in hand shall be submitted with detailed list indicating the present status on Rs. 100/- Stamp paper (however tender form will not be issued to the person who has works in hand more than four times the tendering limit).
- 6. EMD shall be in form of Demand Draft/ Deposit Call Receipt (DCR) /Pay order from Nationalised or Scheduled Bank drawn in favour of The Sarpanch, V.P Curtorim payable at Village Panchayat Curtorim.
- 7. Contractor shall submit separate application for each work.
- 8. Unsealed and conditional tenders will be rejected outright.
- The contractor shall quote the tender excluding GST & GST as applicable shall be paid separately on total value of work executed.
